1. Apologies.

I have apologies from Alison Geen; and a standing apology for Mondays from Paul Turnbull.

2. Declarations of Interest

No amendments have been reported to date.

3. Minutes of the last meeting.

No proposed amendments to date.

4. Police Matters.

I have not received a Police report yet, but have requested one from PCSO Mark Canvin.

Alison Geen reported that Huccaby Bridge had been closed without prior notification to DFPC, which had been customary in the past. DCC Bridge Maintenance has apologised and Alison is liaising with the contractors customer liaison office to ensure we get prior notification in future.

5. Repairs, Maintenance & Highways

The work to replace the metal gutter outside the Post Office in Princetown is provisionally booked in for the end of September, but DCC Highways states this might change due to budgetary issues, weather etc.

6. Dog Control Orders

DFPC have been previously consulted about the proposed new Dog Control Orders, which would introduce a blanket applicability across the whole of West Devon and the South Hams. At the time our only concern was whether we might be charged for WDBC enforcement officers patrolling our Parish. However, the recent public consultation has highlighted that the definition of the areas covered by the Fouling of Land By Dogs Order also includes the whole of the open moorland (the only exemption is Forestry Commission land). Consequently, anyone who fails to poop-a-scoop at, for example, Devils Tor is committing an offence punishable by an £80 fine. This had not been DFPC's interpretation at the original consultation.

Several letters of protest have been published in the Tavistock & Princetown Times Gazette and the WDBC/SHDC officer responsible has responded, effectively saying the order might not be enforced on the moor 'unless there is a problem'. It is poor policy to impose laws/regulations/orders that: are

ambiguous in their applicability; will not or cannot be enforced; or where enforcement policy can legitimately change without consultation.

DFPC may wish to consider writing to WDBC withdrawing support for this order unless there is a further exemption for open moorland in the Parish.

9. Progress reports on previous actions, not on the Agenda

Defibrillators. The telephone has been removed from Hexworthy telephone kiosk and the kiosk will be transferred to DFPC in the next week or so. I plan to have the existing cabinet installed here. After the bureaucracy is complete to upgrade the TAP fund cabinet, DFPC will face around £8 surcharge. I have taken no steps to arrange for the Postbridge defibrillator installation owing to the Smerdon's personal circumstances. This defibrillator will remain at Middle Merripit at least until the second cabinet arrives.

Dartmoor Classic Sportive Wash-up. The letter has been sent and acknowledged by DNPA and Mid Devon Cycling Club. Both organisations are attending a meeting of the Teignbridge Safety Advisory Group (TSAG) which is holding a periodic review of the event. I will let you know the outcome in due course.

Christmas tree lights. Two strings have been purchased as agreed at the last meeting. Following problems with the previous purchase from this company the Clerk has bought them on his credit card and will seek reimbursement.

Banking arrangements. The Co-Operative Bank will not permit DFPC to hold the accounts discussed at the last meeting. The Clerk is still in discussions with various banks to try to find the best option.

Traffic Regulation Order. This is progressing. It was advertised in the Tavistock and Princetown Times Gazette on 31 July. The consultation period lasts until 21 August.

Planning application for Football Club. DNPA have returned the planning application seeking greater details on the proposals. The Clerk is developing these with the Club.

Grass cutting contract. Contracts have not been exchanged as the Clerk is still waiting on a quote from Mike Druett for churchyard subsequent cuts.

Investigate grants for a skate park. No further action to date, based on a prioritisation of workload.

Outline plans for Play Area improvements Phase 3. As planned, no further action pending Emma Derham's availability.

Approach local businesses for chargeable links and adverts. A notice was included in the August Parish Link and Around & About advertising this facility on the DFPC website. Direct approaches to local businesses will take place when the workload permits.
